X Men were found to resolve moral dilemma by choosing the most important

moral rule, overriding other rules.


X In contrast, women gave importance to preserve personal relationships






### stages of growth towards ethics of caring.



pay for it later. Pharmacist refused to oblige him either way. Finally he forcibly entered the Pharmacy and stole the drug.

**X** According to Kohlberg study, men observed that the theft was morally

wrong' at the conventional level, because the property right was violated. 19GET201-Professional Ethics **X** But men at the post-conventional level, concluded that the theft was 'right', as the life of the human being was in danger.

**X** But women observed that Heinz was wrong. They observed that instead of stealing he could have tried other solutions (threatening or payment in installments?) to convince the Pharmacist. Gilligan however attributed the

decision by women as context-oriented and not on the basis of rules ranked

in the order of priority.






